- 5- Pass the training required for registration at the Ministry of Justice or the requirements set out by the Department in this regard.
- 6- Be employed full time by the advocacy firm and not practice any other commercial or professional activity in addition to his/her work within the firm except for teaching or training in a specific field of law or legal practice.
- 7- The approval of the law firm where the advocate will practise the profession provided that the licence of the firm is valid.
- 8- To pay the prescribed fees for the renewal of registration as per the procedure approved by the Department in this regard.

## The following UAE Nationals categories may be registered on the roll of Practising Advocates:

- 1- Those who worked as a judge or a member of the Public Prosecution for a period no less thank (1) year.
- 2- Those who hold a PhD in Law and are legal academics.
- 3- Those who were employed in the legal field at a ministry, or public departments, authorities, and local or federal institutions or any other entity approved by the Department for no less than (2) years.
- 1. Valid Emirates ID.
- 2. Bachelors Degree.
- 3. Passport.
- 4. Certificate of Good Conduct.
- 5. Certificate that the applicant passed the advocacy course of the Judicial Institute (theoretical part).
- 6. Certificate of Practical training for 6 months within an advocacy firm.
- 7. A letter issued by the proprietor of the firm where he/she will practise the profession that the proprietor approves to register the applicant as an advocate in the firm.
- 8. An employment contract legalised by Ministry of Labour.
- 9. A certificate to issued by the commercial licensing authority in the Emirate where the applicant's passport had been issued, stating that no commercial licences are registered under the name of the applicant.
